## WHY WORKPLACE GIVING?

Workplace giving enables people to donate to YWCA Australia regularly through their employer's payroll system pre-tax. The employer will then pay the donation directly to YWCA Australia.

Some organisations choose to match the amount given by the employee to double the impact!

## WHAT DIFFERENCE CAN YOU MAKE WITH \$25\* A FORTNIGHT?

Donating \$25\* pre-tax every fortnight with a matching donation from your employer means that YWCA Australia receives **\$50 a fortnight!** Over a year, your contribution will go towards:

- helping a woman escaping domestic violence to access safe accommodation for six weeks
- supporting four women to furnish new homes after experiencing homelessness
- assisting twenty girls to stay connected with their education and participate in a mentoring or leadership program.
