# **BOARD CANDIDATES**

There are six candidates, three of whom are Young Women aged 30 or under, standing for the three Board positions.

Candidates were asked address the following areas:

- Experience with financial management and oversight
- Experience with housing or property development
- Understanding of the responsibilities of directors

Each candidate was approved by the YWCA Australia Board to stand for election. All appointments are subject to background checks.

The candidates are listed in alphabetical order by their first name.

#### Ashleigh Harradine (Young Woman) NSW

Ashleigh is a passionate advocate for gender equality and DE&I. Additionally, with over five years of experience in financial statement audit at EY Sydney, she has expertise in risk management, regulatory compliance, and financial analysis.

Her leadership style is deeply rooted in her commitment to DE&I. She was recently awarded the Lynne Sutherland Emerging Leader award at the 2024 EY Oceania CEO Awards, highlighting her impactful advocacy for women and the LGBTQIA+ community.

Ashleigh's vision for her role on the YWCA Board of Directors is to leverage both her professional experience and personal passion to further the organisation's mission of achieving gender equality and empowering young women and gender-diverse individuals.
